# PENALTIES FOR INTERNATIONAL ASSOCIATION OF FAIRS AND EXPOSITIONS (IAFE) CODE OF SHOW RING ETHICS VIOLATIONS

Any exhibitors and all other parties found in violation of IAFE Code of Show Ring Ethics are subject to being prohibited from participating in the North Arkansas Jr. Spring Livestock Show for that year.

## IAFE (INTERNATIONAL ASSOCIATION OF FAIRS AND EXPOSITIONS) NATIONAL CODE OF SHOW RING ETHICS

Exhibitors of animals at livestock shows shall at all times deport themselves with honesty and good sportsmanship. Their conduct in this competitive environment shall always reflect the highest standards of honor and dignity to promote the advancement of agricultural education. This code applies to junior as well as open class exhibitors who compete in structured classes of competition. This code applies to all livestock offered in any event at a livestock show. In addition to the IAFE National Code of Show Ring Ethics, fairs and livestock shows may have rules and regulations which they impose on the local, county, state, provincial and national levels.

All youth leaders working with junior exhibitors are under an affirmative responsibility to do more than avoid improper conduct or questionable acts. Their moral values must be so certain and positive that those younger and more pliable will be influenced by their fine example. Owners, exhibitors, fitters, trainers and absolutely responsible persons who violate the code of ethics will forfeit premiums, awards and auction proceeds and shall be prohibited from future exhibition in accordance with the rules adopted by the respective fairs and livestock shows. Exhibitors who violate this code of ethics demean the integrity of all livestock exhibitors and should be prohibited from competition at all livestock shows in the United States and Canada.

The following is a list of guidelines for all exhibitors and all livestock in competitive events:

1. All exhibitors must present, upon request of fair and livestock show officials, proof of ownership, length of ownership and age of all animals entered. Misrepresentation of ownership, age or any facts relating thereto is prohibited.
2. Owners, exhibitors, fitters, trainers, or absolutely responsible persons shall provide animal health certificates from licensed veterinarians upon request by fair or livestock show officials.
3. Owners, exhibitors are expected to care for and groom their animals while at fairs or livestock shows.
4. Animals shall be presented to show events where they will enter the food chain free of violative drug residues. The act of entering an animal in a livestock show is the giving of consent by the owner, exhibitor, fitter, trainer, or absolutely responsible person for show management to obtain any specimen of urine, saliva, blood, or other substance from the animal to be used in testing. Animals not entered in an event which culminates with the animal entering the food chain shall not be administered drugs other than in accordance with applicable federal, state and provincial statutes, regulations and rules. Livestock shall not be exhibited if the drugs administered in accordance with said rules affect the animal's performance of appearance at the event. If the laboratory report on the analysis of said specimen indicates the presence of forbidden drugs or medication, this shall be prima facie evidence that such substance has been administered to the animal either internally or externally. All procedures of specimen collection, preservation, transfer and analysis by Arkansas Livestock & Poultry Commission are presumed correct and accurate and that the laboratory report correctly reflects the condition of the animal at the time the sample was taken, with the burden on the owner, exhibitor, fitter, trainer, or absolutely responsible person to prove otherwise. At any time after an animal arrives on the fairgrounds all treatments involving the use of drugs and/or medications shall be administered by the official Arkansas State Fair veterinarian for the sole purpose of protecting the health of the animal and only with prior written approval of the Livestock Superintendent.
5. Any surgical procedure or injection of any foreign substance or drug or the external application of any substance (irritant, counterirritant, or similar substance) which could affect the animal's performance or alter its natural contour, confirmation, or appearance, except external applications of substances to the hoofs or hors of animals which affect appearance only, and except for surgical procedures performed by a duly licensed veterinarian for the sole purpose of protecting the health of the animal, is prohibited.
6. The use of showing and /or handling practices or devices such as striking animals to cause swelling, using electrical contrivance, or other similar practices are not acceptable and are prohibited.
7. Direct criticism or interference with the judge, fair or livestock show management, other exhibitors, breed representatives, or show officials before, during, or after the competitive event is prohibited. In the furtherance of their official duty, all judges, fair and livestock show management, or other show officials shall be treated with courtesy, cooperation and respect and no person shall direct abusive or threatening conduct toward them.
8. No owner, exhibitor, fitter, trainer, or absolutely responsible person shall conspire with another person or persons to intentionally violate this code of ethics or knowingly contribute or cooperate with another person or persons either by affirmative action or inaction to violate this code of ethics. Violation of this rule shall subject such individual to disciplinary action.
9. The application of this code of ethics provides for absolute responsibility for an animal's condition by an owner, exhibitor, fitter, trainer, or participant whether or not he or she was actually instrumental in or had actual knowledge of the treatment of the animal in contravention of this code of ethics.
10. The act of entering an animal is the giving of consent by the owner, exhibitor, fitter, trainer, or absolutely responsible person to have disciplinary action by the fair or livestock show for violation of this Code of Show Ring Ethics and any other rules of competition of the fair or livestock show without recourse against the fair or livestock show. It is further consent that any proceeding or disciplinary action taken by the fair or livestock show may be published with the name of the violator or violators in any publication of the international Association of Fairs and Expositions, including Fairs and Expositions, and any special notices to members.
11. The act of entering an animal in a fair or livestock show is the giving of verification by the owner, exhibitor, fitter, trainer, or absolutely responsible person that he or she has read the IAFE National Code of Show Ring Ethics and understands the consequences of and penalties provided for actions prohibited by the code. It is further consent that any action that contravenes these rules and is also in violation of federal, state, or provincial statutes, regulations, or rules may be released to appropriate law enforcement authorities with jurisdiction over such infractions.

## Check-Out Procedure

1. *All exhibitors are responsible for cleaning out their stall prior to leaving. If you brought it, you take it home. Any items left on the fairgrounds will become property of the Northwest Arkansas District Fair unless other arrangements have been made.*
2. *Exhibitors must check out with the livestock superintendent*
3. *Failure complete #1 and #2 above will result in a forfeiture of premium check.*

## GENERAL RULES

1. Date for the Northern Arkansas Spring Junior Livestock Show will be on Saturday the last weekend in April.
2. ELIGIBILITY - Exhibitors are limited to youth 5 to 19 years of age the day of show. Exhibitors' project program must be under the supervision of a vocational agriculture teacher or a county Extension agent in the designated area. Exhibitors shall not enter multiple spring shows in a given year, receiving state of Arkansas premium money from more than one show.
4. OWNERSHIP - Exhibitors must own animals to be exhibited upon registration and entry. See special rules for horses.
5. NUMBER OF ENTRIES - Exhibitors will be limited to two entries per class, and 12 animals per species. See special rules for horses, poultry, and rabbits.
6. BREEDING REQUIREMENTS - Only purebred and/or registered animals will be shown in breeding classes of established breeds. Registration papers must be in exhibitors name or animal will be placed in commercial heifer class. See special rules for goats.
7. TIME OF ENTRIES -MUST HAVE HEALTH PAPERS CHECKED BEFORE ENTERING FAIRGROUNDS. Facilities will be available from 6:00 a.m. Saturday through end of show. Note: Boone County exhibitors exhibiting in the Boone County Spring Show may stay overnight Friday.
8. CARE OF ANIMALS - Exhibitors will be responsible for providing feed, water, bedding, and necessary care of animals on display.
9. AWARDS - Points will be awarded as outlined under species classifications. Total points earned in all departments will be divided into available funds to determine point value. Premium money will be determined by multiplying point value by points earned. Premiums will be paid strictly upon the report as rendered by competent judges. This record shall stand as official.
10. LIABILITY - All exhibitors will be under the control and direction of the Management, but the Livestock Show will in no case be responsible for any loss, injury or damage that may occur. Each exhibitor will be solely responsible for any consequential or other loss, injury or damage done to, or occasioned by, or arising from, any animal or article exhibited by exhibitor and for its description as given in the catalog. Exhibitor shall indemnify the Livestock
3. Show against all legal or other proceedings in regard thereto, as well as damage or injury to any other person or property, caused by the exhibitor or any of the animals exhibited by exhibitor, or arising out of, or in any way connected with such exhibition or any of the animals so exhibited.
11. Showmanship classes will include pee wee (under 9 years), junior (9-13 years), and senior (14-19 years) as of January 1, (See special rules for horse show.) Animals used in showmanship classes must be owned by the exhibitor and be shown in class in addition to the showmanship class. (With the exception of pee wee showmanship.) No animals under six months old or over two years old can be shown in showmanship classes.
12. Exhibitors must show their own animals unless an exhibitor has multiple animals in the ring(s) at the same time.
13. There will be a designated area for using generators.
14. Fees are for livestock only, not to reserve space for your show box & equipment.
15. All animal stalls will be assigned by the livestock Superintendent
16. Judging will be based on the American Judging System
17. No Chutes will be allowed in the barn walkways

# HEALTH REGULATIONS

## ARKANSAS LIVESTOCK & POULTRY COMMISSION EXHIBITION REQUIREMENTS COUNTY, JR. DISTRICT, DISTRICT, STATE FAIR LEVEL, AND OTHER SHOWS

1. All animals entering the grounds, including those showing in pet zoos, children=s barnyard animals, Old McDonald Farms, etc. must meet the requirements of their particular species.
2. Arkansas livestock (except for Arkansas sheep, goats, horses, steers and rabbits) must be accompanied by a Certificate of Veterinary Inspection issued within 90 days prior to exhibition, showing the following:

### **ARKANSAS CATTLE**

1. If Arkansas is a Class Free State, Arkansas cattle are exempt from brucellosis testing. If Arkansas is not a Class Free State then the following testing requirements must be met:  
Negative brucellosis test within ninety (90) days prior to exhibition, for females and bulls eighteen (18) months of age and over. All heifers that have calved or are bred must be tested. Animals originating from a Certified Brucellosis Free Herd are exempt if the Certified Free Herd number is shown on certificate.
2. All heifers that are 4-12 months of age shall be vaccinated before entering show.
3. Heifers that were born on or after January 1, 1985, that are over 12 months of age and are not official calfhood vaccinates will not be allowed to show (unless they are from a Brucellosis Certified Free Herd.) This will not apply if Arkansas continues as a Brucellosis Free State.

### **ARKANSAS SWINE**

1. As of July 1, 2001, all swine must have an official premise identification.
2. Animals 6 months old or older to be tested negative for brucellosis within 90 days of exhibition or originate out of a Validated Herd, with Validation number and date of last herd test shown on certificate (barrows exempt from brucellosis testing, but must be pseudorabies tested.)
3. Animals to be tested negative for pseudorabies within 90 days of the exhibition on a test approved by the State Veterinarian or originate directly out of a Qualified Pseudorabies Free Herd, with Qualified Herd number and date of last test shown on certificate.
4. Free of other contagious, infectious, and communicable diseases (erysipelas, atrophic rhinitis, etc.); otherwise they will not be allowed to show and will be released from fairgrounds.

### **ARKANSAS SHEEP & GOATS**

All instate sheep and goats in the state of Arkansas must be identified by an official USDA tag (scrapie tag) or for goats a legible official goat registry tattoo if accompanied by a registration certificate.

If you need a Scrapie ID call 1-866-USDA-Tag for free tags and tagger.

Fair personnel, veterinarians, or state-federal personnel may examine sheep on grounds. Any sheep showing clinical symptoms of Scrapie shall be immediately quarantined in isolation and required to undergo any approved diagnostic tests and shall be consigned to slaughter or destruction with submission of tissues to an approved diagnostic laboratory at the exhibitor's expense.

Commingle (as defined by the Arkansas Scrapie Regulation) of sheep or goats of different flock status as defined by the Voluntary Flock Certification Program (VFCP) is prohibited and must be reported to the VFCP state official and State Veterinarian.

No sheep or goats showing symptoms of disease, particularly foot rot, sore mouth, sheep pox, evidence of fungal infection, evidence of abscesses or with draining abscesses will be allowed to show and may be released by fair officials, veterinarians, or state-federal personnel.

All goats except pygmy or dwarf must be dehorned or have horns tipped or padded for safety.

### **ARKANSAS HORSES**

All horses must be healthy and serviceably sound. A negative Coggins test conducted within the past 12 months of

*show will be required for all animals over 6 months of age. Nursing foals under 6 months of age are exempt from testing if accompanied by negative tested dams. Must have original Coggins when entering premises. Papers will be checked.*

### **ARKANSAS RABBITS**

*Rabbits will be inspected on grounds. No rabbits showing symptoms of disease will be allowed to show.*

### **ARKANSAS POULTRY**

*The requirements are as follows:*

- 1. All in-state poultry, which includes domesticated game birds, quail, pheasants, peafowl, guineas, and turkeys, present at exhibitions in Arkansas shall have originated from U.S. Pullorum-Typhoid Clean or equivalent flocks or have had a negative pullorum-typhoid test within ninety (90) days of the movement to the exhibition (pullorum-typhoid testing on fairgrounds during the fair is prohibited). This information will be documented on a NPIP Form VS 9-3, 90 Day Certificate, NPIP Flock Certification Form or similar certificate which will accompany the poultry during exhibition.*
- 2. All non-certified birds must be banded (leg or wing band), with a sealed band. Wrap-around plastic bands are not acceptable. In-state waterfowl are exempt from pullorum-typhoid requirements.*
- 3. Any poultry showing evidence of infections or contagious disease or insect infestation will not be permitted to exhibit.*

### **Commercial Heifers**

Special classes for commercial heifers will be shown in a similar manner as prospect steers. They will be placed in class by breed groups and may be further divided in classes by weight. Registered animals eligible to be shown in breed classes will not be allowed to show in commercial division.

Age limit of commercial heifers: Not under 6 months of age and not over 2 years of age at date of show.

#### Breed Divisions

American breeds and American breed crosses (all heifers with any Brahman influence). Included will be Brahman, Santa Gertrudis, Brangus, Beefmaster, Braford, Simbrah, Brahmousin, Braler, and any other breed of Brahman derivative or crosses from these breeds. Animals in this division should show some trait(s) of Brahman such as ear, dewlap, hump, etc.

European breeds and European breed crosses (all heifers with any Exotic breeding except those with Brahman blood). Included will be Charolais, Simmental, Limousin, Maine Anjou, Chianina, Saler, and any other breed originating on the European continent or commonly termed Exotic Animals in this division should have some indication of Exotic influence either by color or form.

English breeds and English breed crosses. Included will be principally Angus, Hereford, Shorthorn, and crosses thereof. (English breed crosses with Brahman or Exotic breeds will be classed as Brahman or Exotic crosses rather than English crosses.) Animals in this group should not show traits common to Brahman or European crosses.

Registered Heifers are not allowed to show in the Commercial Heifer Show.

## DEPARTMENT 4 – POULTRY

### Chickens

All recognized breeds and recognized commercial lines and crosses used for market egg and meat production.

Special rules:

1. As required by state law all poultry, including turkeys and excluding waterfowl, present at exhibition in Arkansas shall have originated from U.S. Pullorum-Typhoid clean or equivalent flocks or have had a negative Pullorum- Typhoid test within ninety (90) days of the movement to the exhibition. This information will be documented on a NPIP form VS 9-3, 90 day certificate, NPIP flock certification form or similar certificate which will accompany the poultry during the exhibition.
2. Any poultry showing evidence of infectious or contagious disease or insect infestation will not be permitted to exhibit.
3. Birds will not compete in both single and pen classes.
4. Exhibitors must bring your own feed, water & containers. You are responsible for feeding and watering your exhibit. See health requirements. Marketing condition and quality will be given a major emphasis in judging turkey class.
5. No entry is to be handled by anyone other than the judge, superintendent, or his assistants, or owner, except by written permission.
6. Definition of poultry terms used in judging classes:
  - a. Cock - male bird over one year of age
  - b. Hen - female bird over one year of age
  - c. Cockerel - male bird less than one year of age
  - d. Pullet - female bird less than one year of age
  - e. Young trio - cockerel and two pullets
  - f. Old trio - cock and two hens
  - g. Young pen - 3 pullets
  - h. Old pen - 3 hens
7. Each exhibitor may show one entry in each broiler class. Three broilers constitute an entry and may be of any meat type, breed or cross.
8. Exhibitor will be limited to no more than six entries.
